



Terms and Conditions

Registration: You need to register and provide the information requested in our registration form in order to participate in our Internet auctions. You can register online at www.futbolasta.com or call 1 (321) 352 4317 to register with your bidder information in order to participate in FUTBOLASTA AUCTIONS, LLC ("FUTBOLASTA"). You will only need to register once. As part of the registration process, you will create a User ID and password, which can be used in all future auctions of FUTBOLASTA. If you do not recall your User ID or Password, you can obtain this information by clicking [here](#). You may also call us at 1 (321) 352 4317 or email us at contact@futbolasta.com if you have additional questions or concerns. You can only register at FUTBOLASTA if you are at least 18 years old.

Please note that by completing the registration form and/or by placing a bid in our Internet auctions, you agree and acknowledge that you are accepting all the terms and conditions listed herein and that you are legally bound by our auction procedures and conditions of sale. Please carefully read the rules below before registering and/or placing a bid at FUTBOLASTA.

1. Bidding: All auctions of FUTBOLASTA are online and all bids must be placed and accepted online. The biddings begin as soon as a particular auction is launched in our website and the ending time for a particular auction will be listed on our

website. All items will be sold to the highest bidder at the closing time. If you are outbid, you will be notified by email (please be sure your email settings are set to receive our outbid notices since these emails might be identified as spam).

Please remember that placing a bid is a legally bound contract and that you may not retract from a bid after it is placed. FUTBOLASTA will only accept online bidding from registered users who have obtained a valid User ID and Password and are in good standing.

2. **Minimum Bids:** The minimum bid is the lowest amount that we will be accepted for a lot.
3. **Reserves:** A reserve is the confidential minimum price that a consignor will accept for its item. Therefore, if the reserve is not met, the lot will not be sold. Any lot that features a reserve price will indicate if the reserve has been met or not.
4. **Bidding Increments:** Items will be sold to the highest bidder. Bids can be no lower than the minimum bid listed in the website. When bidding, you will be able to view the current high bid for the particular lot. Bidding increments are set for all lots at ten (10) percent increments.
5. **Buyer's Premium:** FUTBOLASTA will add a buyer's premium of 22% to the winning bid, which shall be payable by the purchaser as part of the total purchase price. All bidders must pay buyer's premiums, no exceptions. For example, if the final price for a lot is one thousand dollars (\$1,000.00), the buyer's premium of 22% will be add for a total purchase price of one thousand two hundred and twenty dollars (\$1,220.00) (plus shipping, insurance and sales tax, if applicable).

6. **BIDDING & ENDING RULE:** Bidding begins immediately upon the launch of the auction on our web site. Preliminary bidding will end at 11:00 AM Eastern Time on the auction closing date. To bid on a lot after 11:00 AM Eastern Time you must have placed a bid on that lot prior to 11:00 AM Eastern Time. Thus, if you are the only bidder on a lot at 11:00 AM Eastern Time on the auction closing date, the auction software will disallow additional bidding for that lot and you will be declared the winner. Bidding prior to 11:00 AM, Eastern Time as well as after 11:00 AM, Eastern Time (the latter regulated by the 15-Minute Rule), may occur online. Bidding for registered users who have obtained a User ID and Password is available 24 hours, 7 days a week. Beginning at 11:00 AM Eastern Time on the auction closing date, bidding will be extended in accordance with the terms of the "15-Minute Rule" (with all items ending at the same time). After 11:00 AM Eastern Time, "Time Left" in the user interface will count down in real time the amount of time remaining until such time as no lots receive even a single bid for a period of approximately 15 minutes, at which time the auction will officially close and "Time Left" will read "Auction Has Ended."
7. **Product Information and In-person product viewing:** All lots and descriptions are available for viewing at www.futbolasta.com. Our lot descriptions are as accurate and up-to-date as possible. Upon request, we also offer detailed phone descriptions and can email or fax you additional information as needed. You may also contact us by phone or email to view a lot in person up to three (3) days prior to the final day of auction close at our location during business hours. We strongly encourage bidders to take advantage of these options.
8. **Invoicing:** Invoices will be emailed to all winning bidders within three (3) days after the close of the auction. The invoice will contain the total, which includes the winning bid amount, the 22% Buyer's Premium amount, shipping, packaging and insurance amounts and sales tax, if applicable. All invoices should be paid in full within ten (10) days of the close of the auction. If an invoice has not been

paid within fifteen (15) days of invoice date, the bidder's credit card on file will be automatically charged for the full amount due. FUTBOLASTA reserves the right to grant extended payment terms for pre-approved buyers prior to auction close at its discretion. Arrangements to extend payment terms must be made prior to bidding. Failure to pay your invoice in a timely manner will result in your bidding privileges being revoked. We reserve the right to charge interest on past due unpaid balances at 1.5% per month until paid.

9. Payment: The accepted forms of payments are by personal check, money order, certified check, cashier's check, and wire transfers. Please note that wire transfers will be subject to a \$25.00 processing fee. Special arrangements can be made prior to auction close to accept to receive payments by PAYPAL, Western Union and Moneygram. We do not accept credit card payments.

10. Shipping: The buyer is responsible for all shipping, packaging, freight, and insurance. These costs will be added to all invoices. Items will be shipped as soon as possible after the payment has cleared. Most lots will be shipped via FedEx with tracking, and signature confirmation. FUTBOLASTA will ship all lots with a winning bid greater than \$1,000.00 via FedEx to a physical address with an adult signature requirement. If you would like to pick your items up in person at our Miami, Florida location, we will waive the shipping and handling charges, however sales tax will be charged in accordance with Florida tax codes. All items will be shipped via FedEx, or picked up in person at Florida, and in some cases outside US but only via International FedEx services with no exceptions. Extremely large or heavy items may require special shipping arrangements. If you are interested in bidding on an oversized item, we suggest calling before bidding to determine the approximate shipping cost. All international items will be shipped via FedEx and will be declared at full value. The buyer is responsible

for all duty, brokerage, customs charges and/or similar charges on items shipped internationally.

11. Taxes and Fees: Shipments made to Florida will be charged appropriate local sales tax unless the bidder has provided to us a Florida tax exempt resale certificate. Certain countries, regions, states, or municipalities may charge taxes or fees to buyers living in their jurisdiction.

12. Returns and authenticity: All lots are sold "as is". All sales are final. No returns are accepted. No refunds are given. The provenance and authenticity of items offered in this Auction have been researched extensively. FUTBOLASTA has over fifteen (15) years of experience in the soccer industry, and we will be the final determinant of the authenticity of each and every piece (lot) it sells. We are not bound by the opinion of grading services, outside authenticators, or so-called "experts". Letters of Authenticity (LOA's) if applicable or necessary from third-party, as well as those from relevant sources and to establish provenance, are indicated in the lot descriptions online at www.futbolasta.com and in our Auction Catalog. Notwithstanding FUTBOLASTA efforts to verify authenticity, FUTBOLASTA makes no guarantee or representation as to the authenticity of the lot. Property shall not be considered non authentic solely because any damage, and/or restoration and/or modification of work.

13. Non Payment of Items: If a winning bidder does not honor his or her bid with payment in full per the auction rules, then it is agreed that FUTBOLASTA, may, at its sole discretion, sell the lots to the under bidder, offer the lots again in a future sale, or hold the defaulting buyer liable for the entire purchase price. In either case, it is explicitly agreed that the non-paying winning bidder will be responsible for any and all losses incurred, and also responsible for all service charges and/or commissions related to the subsequent sale and that the non-paying winning bidder explicitly agrees to pay any and all costs of collection

including reasonable legal fees incurred by FUTBOLASTA in the collection of these losses, if necessary. In addition, nonpaying bidders understand that FUTBOLASTA may, at its discretion, share their information with other auction houses.

14. Errors and descriptions: Please be sure to check the website for the most detailed descriptions and product images. The website will always have the most detailed and up to the minute descriptions on all items, as it can constantly be updated. The website may be updated during the auction to provide additional images or product information. All measurements and weight details of lots are approximately. Any error in a FUTBOLASTA listing or lot description, whether typographical, photographic or technical, will be dealt with at our sole discretion.
15. Ownership of Items: Some of the items being offered for sale may be owned by FUTBOLASTA, its affiliates, or its employees.
16. FUTBOLASTA reserves the right to: (i) accept or reject any and all bids or bidders at its sole discretion, (ii) remove any item from auction at any time, and (iii) postpone or delay an auction for any reason without recourse from any bidder or prospective bidder.
17. Consignor bidding and/or shill bidding are strictly prohibited. Bid manipulation of any kind is expressly forbidden. A consignor is prohibited from placing any bids or arranging to have bids placed on his behalf by friends or family members on his own items. Shill bidding is any bid(s) placed by a person or persons to drive up the final price without intent to actually pay and take ownership of the winning lot. It is prohibited to make bids in a false name or with an invalid payment method, even if our software initially accepts such a bid. Anyone found

guilty of this will be prosecuted to the fullest extent of the law and banned from future auctions.

18. FUTBOLASTA may occasionally experience Internet or service outages and may periodically schedule system maintenance and other purposes, during which bidders cannot participate or place bids. If such outages occur, we may at our discretion extend bidding time for the auction, and/or allow a bid to be placed by a bidder who was unable to bid by deadline due to lockup or Internet traffic. FUTBOLASTA is not responsible for system errors and/or software problems if they occur during an auction. Exclusive Dispute Resolution Process: All claims, disputes or controversies in connection with, relating to and/or arising out of your participation in the auction and/or the FUTBOLASTA website (whether as a consignor, bidder or otherwise) including any purchase of any item, any description of an item, returns , authenticity and any damage to an item whether asserted in contract, tort, or under any Federal or State statute or regulation shall be exclusively heard and decided by arbitration conducted by and under the rules of the American Arbitration Association. The location for all such arbitrations shall be in Florida. The arbitrator's award may be enforced in any court of competent

jurisdiction. The fees and costs of the arbitration shall be split by the parties and each party shall be responsible for their own attorney's costs. This Agreement and any claim shall be determined and construed under the laws of the State of Florida. In the event that any matter including actions to compel arbitration, construe the agreement, or otherwise needs to be litigated, such litigation shall be exclusively in the Federal or State courts located in Florida, and if necessary the corresponding appellate courts. For such actions, the consignor, bidder, successful purchaser, or Auction participant also expressly submits himself to the personal jurisdiction of the State of Florida.
